NOTES TO PHYSICIAN

Section 5 - FIRE FIGHTING MEASURES

EXTINGUISHING MEDIA

Section 7 - HANDLING AND STORAGE

EYE

In the event of chemical exposure, begin eye irrigation immediately and remove contact lens as soon as practicable.
